## **Shenandoah Valley BBQ Fest Official Rules and Regulations**

1. Contestants must abide by the Rules and Regulations of the Kansas City BBQ Society as outlined on pages 3 & 4 on this registration packet.
2. Entries are accepted on a 1st come, first selected basis with a limit of 49 teams. Teams are encouraged to submit an early entry. No entries will be accepted after September 31, 2018.
3. All fees must be paid up front at the time of Registration. Make all checks payable to: ***The Shenandoah County Fair Association.***
4. Registration fee includes (1) 20 foot x 30 foot space and access to water. Should you require additional space, contestants **MUST** notify the Shenandoah County Fair Association at 540-459-3867. Space will be allocated on a first come, first serve basis. Please notify the Fairgrounds by October 1st if you require additional space.
5. All local, county and state ordinances and statuses must be followed.
6. You may arrive anytime after 8am on Friday, October 12. Should you need to arrive earlier, please contact the fair office at 540-459-3867.

### **People's Choice Competition Rules and Regulations**

1. **Those participating in the People's Choice Competition will receive a \$100 reimbursement within 30 days of the competition and be eligible for an additional \$1000 in prize money (1st place- \$600, 2nd- \$300, 3rd place- \$100).**
2. Contestants can enter their choice of meat. You must provide a minimum of 50 lbs. to be eligible to compete for the People's Choice Competition. Keep in mind, more samples means more votes!
3. The People's Choice Competition will begin **AFTER** submitting entries to the judges for the KCBS competition at 2pm and conclude prior to the awards ceremony at 4:30pm. Placement in the People's Choice category will have no effect on scores for Grand Champion or Reserve Champion for the KCBS portion of the competition.
4. The public will come to your space around the track for tastings. Those participating in the People's Choice competition will be provided with a marker indicating that they are providing samples. Sample cups and utensils will be provided.
5. Contestants are encouraged to sell their own sauces and spices. Offering samples in the People's Choice Competition is a great way to market your product to the public. Be sure to take advantage of this great opportunity!
6. Contestants are required to abide by all local, county and state ordinances and statuses including obtaining a permit from the Virginia State Health Department. The current health department fee is a \$40 (calendar) yearly fee payable with the first permit of the year. That fee is a statewide fee so if a vendor has already paid \$40 anywhere in Virginia this year no additional fee is needed (proof may be required). **ALL APPLICATIONS MUST BE SUBMITTED TO THE HEALTH DEPARTMENT AT LEAST 10 DAYS PRIOR TO THE EVENT.** Virginia Jeffries is our local contact for the Virginia Health Department.
